Small Farmers Agribusiness Consortium Kerala (SFAC) is the implementing agency of the RKVY FPO Promotion Scheme 2019-20.

The responsibility of monitoring the project at District and Block level resides with concerned PD ATMA and ADA respectively. The department officials such as Agricultural Officers/Assistants play a pivotal role in project activities such as FIG meetings, mobilisation of farmers, scheme orientation etc., along with the ABPAs. VFPCK officials are involved in three FPO locations in Wayanad, Thrissur and Thiruvananthapuram Districts.

Through e-tendering process agencies experienced in the agribusiness ecosystem and in handholding FPOs are selected as Agri Business Promoting Agency (ABPA) and Project Monitoring Unit. ABPAs are allocated 5 Zones and each Zone will comprise of 10 new FPOs to be formed and 10 existing FPOs to be strengthened. The Project Monitoring Unit Consulting Agency is Grant Thornton Bharat LLP.

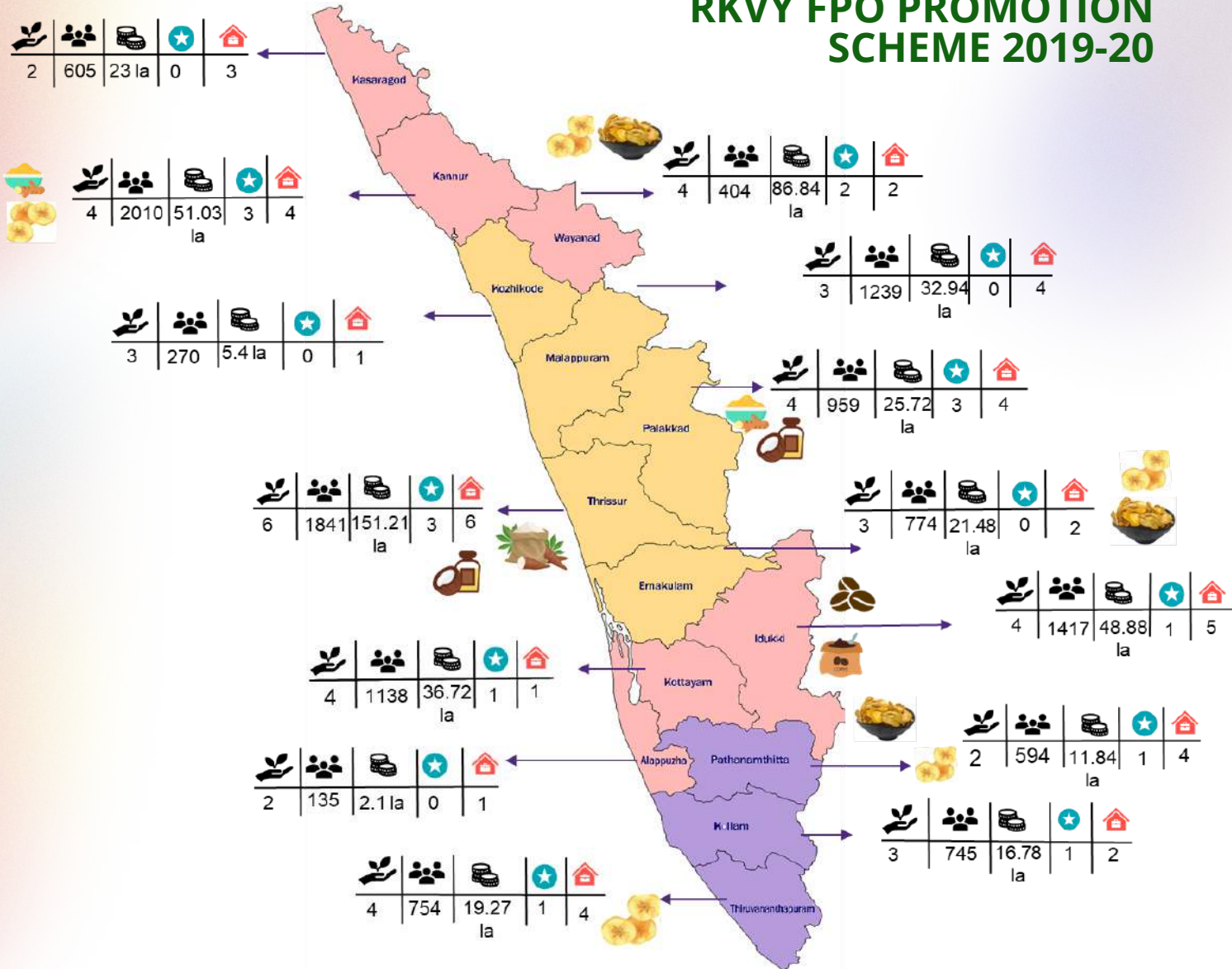

Wayanad district is a leading area in Kerala for Banana cultivation, both in terms of area and production. Located in the Kalpetta Block, Wayanad Banana Production and Export Farmers Producer Company serves major Banana-growing regions like Padinjaraathara, Ambalavayil, and Valad Grama Panchayats, where small and marginal farmers predominantly cultivate Bananas. A key activity of the FPC is trading local produce, which helps farmers with farm gate collection and better price realization.

6,91,583 Kg of Banana procured from the local farmers. Rs. 0.50 to Rs. 1.50 per Kg higher price from open market

The FPC has identified markets in the districts of Pathanamthitta, Thrissur, Alappuzha, Ernakulam focusing wholesale markets and also have tie ups with Banana based value addition units.

Additionally, the FPC has acquired 25 cents of land with plans to establish a packhouse and processing unit for banana value addition in the near future.

Pathanamthitta district in Kerala, India, is known for its agricultural productivity, with a focus on crops like paddy, rubber, coconut, and spices like pepper and ginger. Paddy is the dominant crop, with the district accounting for a significant share of Kerala's total paddy production. Kodumon FPC situated in the Block of adoor and engaged in procurement and sales of GI tagged Kodumon rice and its value-added products. with the support of several department schemes the FPC got a rice processing mill to run, honey cola drinks vending machine, and nursery etc.

The company has opened two collection centers, set up a coconut processing unit, and established office infrastructure, a rice mill, and a dedicated vehicle for transportation. These facilities have been pivotal in enhancing the efficiency and effectiveness of the company's operations.

Spezia Idukki Farmers Producer Company, based in Adimali Block of Idukki District, is a prime example of an FPC where women make up the majority, with over 80% of shareholders being female. The company comprises 49 Farmer Interest Groups and has 640 shareholders.



Under the umbrella of FPC around 10 FIGs led by women members focuses on value addition of products such as Nutmeg Squash, candy, Jackfruit chips, pickles etc.,



The FPC is having 3 collection centres at Nedumkandam, Upputhodu and Kalvary mount and a new processing unit is operational for producing masala and curry powders. The brand name is '**Spezia**' and have many SKUs (Stock Keeping Unit) in the product line.

Way Forward: The Keralagro brand shop is set to open before September 2024. The FPC also aims to fully operationalize its spices nursery. Additionally, the FPC is working on multiple partnerships with retail chains for curry powder supply and with exporters for products like Jackfruit payasam and Idichakka cutlet.

Spezia Idukki FPC focuses on adding value to local produce, like Jackfruit seeds and Nutmeg aril, by developing innovative products. This approach aims to boost income for women and local farmers. The FPC also plans to expand with a larger production unit for jackfruit and other fruits and vegetables in the near future.

VALUE CHAIN CROPS: RUBBER

Rubfarm Producer company Ltd is the only FPC under the RKVY FPO Promotion Scheme 2019-20 that is focusing solely on the value chain crop of natural rubber. Kerala standing as India's largest rubber-producing state, contributes approximately above 70% of the country's rubber output. Rubfarm Producer Company with its leadership team comprising of experts including Retired scientists, large scale farmers and experienced agri business professionals is an advantage for the growth of the FPC. The FPC strongly advocates value addition from rubber as commodity price of natural rubber is ever-fluctuating due to the uncertain demand from the tyre sector. To make the price steady, it is necessary to strengthen the non-tire sector by introducing novel products. One big outdoor pot contains 180-250 g of natural rubber.

Other Activities: Apart from nursery, the FPC is largely focusing on value added products such as indoor pots made from natural rubber and also grow bags, gloves, finger caps, rubber bands etc.,

- In a short span, the FPC participated in several exhibitions to market their unique products.
- Keraleeyam, Plantation expo, Chaithanya agri fest kottayam, Tarang Fest by NABARD are some of those. Approximately Rs. 1.25 Lakhs worth products were sold in these events.

Nursery:



Rubber tree stumps and saplings supplied under the Rubber Board of India scheme named NE MITRA mission to North East states. Last year **1.5 Lakhs saplings** supplied. This year 3 Lakhs saplings are targeted.

Way Forward: Rubfarm Producer Company plans to establish a production unit for value-added natural rubber products, supported by Rs. 25 lakhs from SFAC Kerala for a packhouse/processing unit. The FPC is optimistic about setting this up soon and aims to expand its product range with a larger production unit in the near future. The FPC is also exploring partnerships with Suchitwa Mission for grow bags and Rubber Products Incubation Center, which are expected to drive significant business growth.

With the aim to improve the living standards of the tribal populace in Athirappilly Gramapanchayat multiple efforts are being taken by the Department of Agriculture Development and Farmer's Welfare, along with other departments like Forest, and Tribal Development and support of UNDP. By ensuring an end to the age-old exploitation of tribal societies at the hands of intermediaries, the Athirappilly Tribal Valley FPC is able to effectively intervene and bring a change in the existing scenario.

The FPC is engaged with procurement, value addition and sale of forest produce such as coffee, Arrowroot, Black pepper, Honey etc., Subsistence farming of crops and ensuring a thriving sustainable global market for the products like medicinal plants, honey and other Non-Timber Forest Products sourced from the rainforest is a major objective of the FPC to support the tribal community.



All the cropped area is certified organic under the PGS system and the products also have Rainforest Alliance certification.

The FPC primarily sells products through offline channels at major expos and melas, with an online sales portal also available. Additionally, the FPC has established **two collection centers** in the tribal colony, reducing the distance to market for farmers from 70-80 km to under 20 km.

VALUE CHAIN CROPS: TAPIOCA, BANANA, VEGETABLES

Perumbavoor Farmer Producer Company, located in Ernakulam district, operates in an area with significant production of Tapioca, Banana, Pineapple, and various vegetables. The FPC's primary activity is running an auction market where farmers bring their produce to a central, accessible location. Potential buyers then purchase the produce in bulk, facilitating efficient transactions between farmers and buyers under the supervision of FPC.

The FPC's consistent organization of the weekly Friday auction market has built trust among a growing number of farmers, encouraging their participation. This has eased the difficulties they previously faced, such as uncertainty about prices and finding a marketplace when selling their produce on their own. - The FPC runs an Organic Input shop, made possible by the initiative of Smt. Shyby Rajan (BoD), who took the lead after completing the DAESI course.

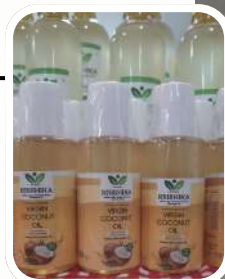

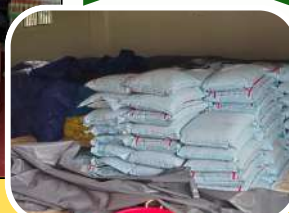
